Audit Fee	\$230/unit	any person who doesn't fit a special category and isn't already in a degree or certificate program
Alumni Audit Fee	\$120/unit for up to two courses per year. Beyond max is regular rate.	alumni; students who have been awarded a degree or certificate from PSR as verified by registrar
Alumni for credit tuition	\$355/course up to one course per year	alumni; students who have been awarded a degree or certificate from PSR as verified by registrar
Employee Audit Fee	\$0/course for full time employees up to two courses per semester if no course for credit is taken. If one course is taken for credit, then the maximum for audit is 1 course. Beyond max is regular rate	Full time PSR employees. Part time PSR employees have a pro-rated rate
Employee for-credit Fee	\$175/course for full time employees up to one course per semester for all terms except for Summer courses at non-PSR schools; part-time employees have a pro-rated reduction based on hours and may take only PSR courses. Beyond max is regular rate	Full time PSR employees. Part time PSR employees have a pro-rated rate
Adjunct faculty and other guests of PSR for audit	\$120/unit for up to two courses per year. Beyond max is regular rate.	Any PSR adjunct in that has taught as for PSR as an adjunct within 5 years. Guests of PSR are individually determined by Office of the Dean & Registrar at PSR, not GTU

Current Field Education Mentors for Audit	\$120/unit for up to two courses per year. Beyond max is regular rate.	FE mentors who have supervising PSR FE students within the past 5 years, verified by the FE dept.
Current Field Education Mentors for Credit	\$355/course for up to one course per year. Beyond max is regular rate.	FE mentors who have supervising PSR FE students within the past 5 years, verified by the FE dept.

Emeriti Employees for-credit tuition	\$355/course for up to one course per year. Beyond max is regular rate.	Regular staff and faculty who have formally retired from PSR after working at PSR for at least 15 years with emeriti status
