Master of Divinity (M.Div.) Program Milestone

Overview

The **Middler Review**, a meeting held at the <u>midpoint</u> in the M.Div. program—both Congregational and Chaplaincy tracks—is a comprehensive review of your theological and vocational formation within the mission of PSR and the Learning Outcomes of its Master of Divinity program.

Middler Review Objectives

The Middler Review meeting is a time of support, assessment, review, and planning. The materials provided to the Middler panelists support their assessment of your academic progress and your ability to articulate your vocational formation within the Master of Divinity program. The panelists use these materials to provide input to you about your strengths observed during praxis and classes, the "growing edges" in your theological/spiritual clarity and vocational skills, and recommendations for further education through academic courses, workshops, and other resources.

As the central element of the Middler Review, your **Middler Theological and Vocational Essay** offers an opportunity for you to

- reflect theologically, critically, and practically on your formation to date in the M.Div. program,
- demonstrate your integration of scholarly theological and social analysis disciplines with your vocational models, spiritual practices, and leadership praxis, and
- articulate a vision of your plans for transformative, spiritually rooted leadership.

MIDDLER REVIEW PANEL MEMBERS

The Middler Review Panel is usually comprised of 3 to 5 people selected for their expertise in one or more components of the review and for their experience with your formational journey. Based on the Middler materials provided, all panelists should come prepared with input and questions about your demonstrated growth and strengths, important growing edges, and plans for continued development of your growing edge skills. Panelists should also be prepared to complete an online final assessment of the student based upon their Middler meeting observations.

Panel Member Roles & Responsibilities

Each member of the panel has a specific responsibility for assessing the materials provided by you:

- Faculty Advisor (required): The faculty advisor
 - o reviews your current transcript and discusses your Vocational Academic Plan, Spiritual Formation Plan, and degree worksheet;
 - o consults with you to review and revise the Theological & Vocational Essay;
 - o chairs the review meeting process.
- Field Education Mentor or CPE Supervisor (required)
 - This panel member is a minister, church leader, agency administrator, or certified CPE Supervisor who provided direct engagement with your work in a field setting for a vocation of service praxis. The mentor/supervisor reviews all materials distributed to the panel from their observation of your practice of the ministry of care.
- **Student Peer** (required)
 - This peer should have engaged with you in the academic environment and should be able to offer personal assessment of your formational journey. If requested, the peer may take notes to assist you with your post-review reflection.
 - o It is not necessary for the peer to be in the M.Div. program. However, the peer should have taken several 1st tier Stackable Curriculum courses with you (e.g., Rhetorical Use of Text, Transformative Leadership, Spiritual Formation, Design Thinking. For Social Change.)
- Denominational Representative (required if student is pursuing ordination)
 - This panel member is an ordained church leader who is familiar with the Minister-in-Training expectations and process for your denomination. The denominational representative examines your materials from the perspective of these ordination requirements and the status and needs of your progress in meeting them.
- Second Faculty Member (optional)
 - o In some cases, the Office of Academic Affairs appoints this panel member, in consultation with the faculty advisor and you. This member's primary role is as a second academic reader of the written essay and to provide additional academic response to the oral presentation.

Middler Review Materials and Preparation

You are responsible for scheduling, planning, inviting, and gathering your Middler attendees (panelists.) Your faculty advisor chairs the meeting and provide the Zoom meeting link.

You need to provide all panelists with these materials for review <u>at least one week before</u> the scheduled Middler meeting:

As part of the opening of the Middler Review meeting, you will give a **10–15-minute oral presentation** to highlight your essay. This presentation can be ad lib or prepared; you are not required to submit your presentation to your advisor or panel. You are welcome to use slides, music, and videos to enhance your presentation as long as these are pertinent to this narrative of your formation.

MIDDLER REVIEW MEETING STRUCTURE

- 1. Each panel member introduces themselves and their role in the Middler Review process.
- 2. You speak for 10-15 minutes about your formational journey, emphasizing aspects of your Theological and Vocational Essay.
- 3. You inform panel members of any areas about which you would like specific input (e.g., your nervousness about speaking publicly outside of church.)
- 4. You leave the meeting or are put into Zoom breakout room (for about 15 minutes.)
- 5. Your advisor facilitates the panel members in producing discussion points: questions, need for clarification, observed growth over time, strengths, current growing edges, etc. The panel determines how to consolidate and organize the order, questioner, and examples of input for the discussion with you.
- 6. You return to the room. Panelists engage in presenting and discussing their input with you. This discussion should be warmly interactive; criticisms should be presented within the context of your strengths and growing edges. You are expected to engage the panel during this discussion. Ask for clarification, advice, and examples.
- 7. Your advisor checks with everyone to determine when your Middler Review has been successfully fulfilled. Final statements do not need to be formal; often everything is covered during your discussions.
- 8. Your advisor provides the panel members with a link to the **Panelist Post-Middler Student Assessment** and the advisor's email address. As each panelist submits their assessment, a pdf copy will be sent to the advisor, the panel member, and the PSR Office of Academic Affairs. (see Appendix for printout of this form.)

9. Your advisor will create a summary of these assessments. You and your advisor will meet within 2 weeks to discuss this summary. You will them submit your Post-Middler Final Report, demonstrating your understanding of your Middler Review experience. Your Middler essay must be uploaded to this online form. Once you submit this report, you have successfully completed your M. Div. Middler milestone! (see Appendix for a printout of this form)

Middler Review Essay

The **Middler Theological and Vocational Essay** offers an opportunity for you to reflect critically and theologically on your formation to date in the M.Div. program, demonstrate your integration of scholarly disciplines with community spiritual practices, and articulate a vision of your vocational goals for transformative and spiritually rooted leadership.

This **15–20-page essay** is a statement of deep reflection of your personal and academic journey. It is explicitly **not** an autobiography. It should include how the classes you have completed and are currently taking, your community participation at PSR and beyond, and the social justice advocacy you have engaged have deepened your vocational call.

It should articulate your comprehension of the Learning Outcomes of the M.Div. program in conversation with the teachings of your religion/wisdom tradition and your vocational goals. It should cogently articulate the specific experiences—through course work and praxis—that have shaped your formation toward a ministry of service, and how this journey has deepened and clarified your "transformative leadership identity" and your vocational plans.

This essay should be a congruent narrative that **demonstrates your intentional and comprehensive integration** of:

- 1. Your awareness of the theological/spiritual perspectives and vocational goals you held at the program's start,
- 2. Your process of being changed in your understanding and perspectives (with explicit references to insights from academic and praxis experiences,) and
- 3. How these changes are the foundation of your current theological/spiritual perspectives and your vocational plans.

The following essay prompts are guidelines for this deep reflection essay. This grid includes the connection between the M.Div. program learning outcomes and the areas for reflection. It also provides suggestions for the papers and projects from your 1st Tier courses in the Stackable Curriculum that could provide insights and resources relevant to your essay.

Your essay does not need to follow the exact outline of these prompts or answer each prompt question specifically. However, your complete essay must cover these areas of critical reflection thoroughly.

Middler Essay Evaluation Rubric

Your faculty advisor will use this rubric to assess the qualities of your Middler Theological and Vocational essay. This essay is a capstone project that must be submitted with an evaluation, the same as any final paper and project in your academic courses. There is no academic grade associated with the completion of the Middler essay. Still, it is part of your academic record as evidence of your successful completion of the Master of Divinity degree.

You and your advisor can use this rubric to fine-tune your essay. Your advisor will submit their official assessment with the final essay version you use as part of your Middler Review document package to the panelists.

 evaluation for each statement.
- Use the Comments section to expand on your assessment. While not required, it is useful to provide comments in order to assist more informed discussions during your Middler Review Meeting.
- Once you submit your responses, you will receive an email with an attached pdf copy of this assessment to include in your document package sent to the panelists.

PANELIST POST-MIDDLER STUDENT ASSESSMENT

At the close of your Middler Review meeting, the Faculty Advisor/Chair will provide each panelist with a link to an online assessment form (see form printout in the Appendix) and the faculty's email address.

Once again, this assessment uses the same M.Div. Program Outcomes and Reflection Questions as was used in your Self-Assessment and Middler Essay.

The panelist will respond to each statement as "**The student is able to...,**" based upon their perceptions and insights about your formation discussed at the Middler meeting.

Although the assessment statements are the same, the panelists are <u>not</u> evaluating you on the **accuracy** of your self-assessment. They are providing you with additional input for reflection based upon their perspectives on what you demonstrated to them during your Middler Review.

STUDENT POST-MIDDLER FINAL REPORT

Your advisor will create a summary of the panelists' assessments. You and your advisor will meet within 2 weeks to discuss this summary. You will them submit your Post-Middler Final Report, demonstrating your understanding of your Middler Review experience. (see form printout in Appendix)
